Payment Terms

Full Time Program

1. Fees shall be payable in 3 instalments of Rs. 5,000 each.
2. First instalment shall be payable at the time of registration and enrolment. (Rs. 1,000 shall be non-refundable and Rs. 4,000 refundable, if the applicant wishes to withdraw after enrolment and prior to commencement of the program.)
3. Second instalment shall be payable after 6 weeks into the program.
4. Final instalment payable 2 weeks before conclusion of the program.

Part - time and Specialized Program
